Overview of our services.

Namekagon Transit serves Sawyer, Washburn, Barron and southern Bayfield counties, and the LCO reservation.

In **Barron County** we offer rides with a **varying daily schedule**.

Other Namekagon Transit services include **three regular deviated fixed routes** within **Hayward** and the **LCO reservation**. You can schedule a stop that deviates from the route of up to three-quarters of a mile. You may transfer free between the three deviated fixed routes at the LCO Casino and from other transit services in Hayward.

The **Barnes/Cable/Drummond/Hayward** route runs every Tuesday.

The **Hayward/Trego/Rice Lake** route runs every first and third Wednesday

The **Winter/Radisson/Hayward** route runs Monday through Friday.

In **Washburn County** we offer daily service between **Spoooner and Shell Lake**. Every second and fourth Wednesday we have service between **Minong and Chicog**.

We can also assist you in finding and scheduling transportation outside of our service area.

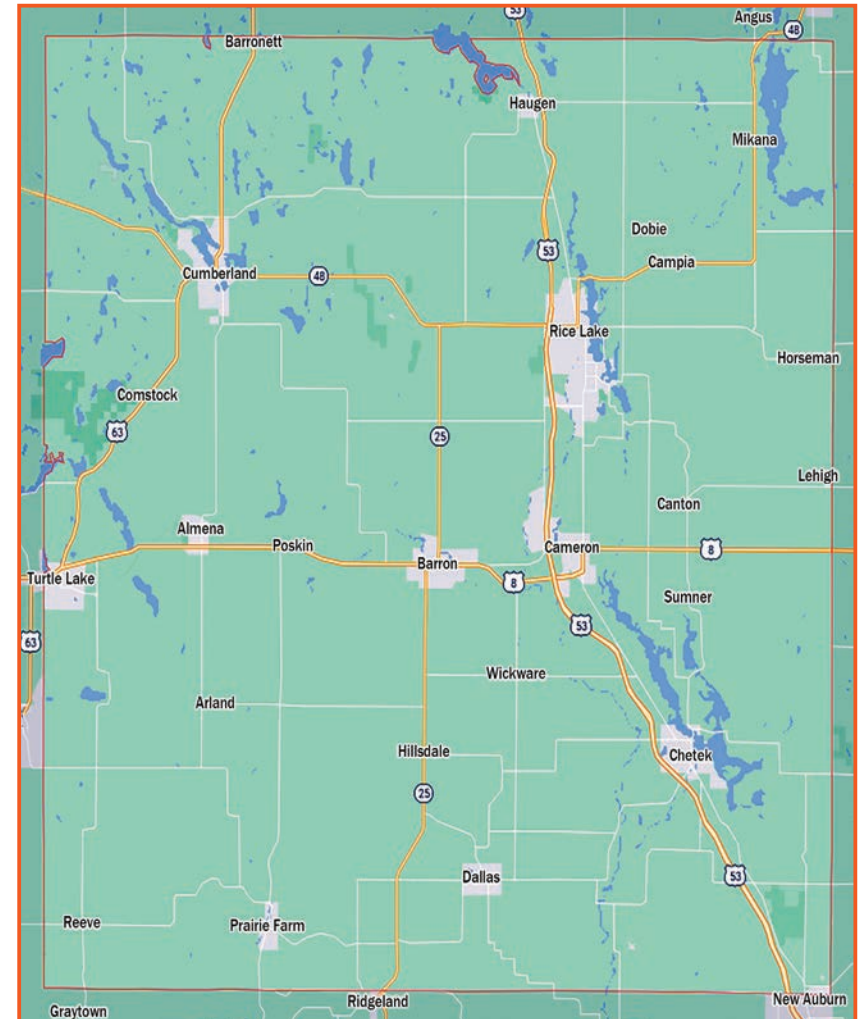
